Recent leasing activity within AMB's China development portfolio includes:

-- 84,100 square feet (7,800 square meters) leased to two third-party logistics providers at AMB Beilun Port Distribution Center, a development project located in the Ningbo Economic & Technological Development Zone (NETDZ), one of China's premier business and port areas.

Second quarter leasing activity within AMB's China operating portfolio includes:

-- 143,200 square feet (13,300 square meters) at AMB Jiuting Distribution Center, an infill location in Shanghai with rapid access to the A8 and A9 expressways. This customer renewed its lease of approximately 76,700 square feet (7,130 square meters) and leased an additional 66,500 square feet (6,170 square meters).

Including these agreements, the company has leased more than 700,000 square feet (65,030 square meters) to date this guarter and 1.22 million square feet (113,150 square meters) since the beginning of the year in China.

AMB's Asia portfolio totals approximately 16.3 million square feet (1.5 million square meters) of operating and development properties.
