Nippon Prologis REIT Prices New Investment Units

SAN FRANCISCO, Sept. 8, 2014 /<u>PRNewswire</u>/ -- Prologis, Inc. (NYSE: PLD), the global leader in industrial real estate, today announced that Japanese real estate investment trust Nippon Prologis REIT, Inc. (NPR) priced new investment units at 250,096 Japanese yen per unit. The offering will comprise a domestic placement of 92,250 units and an international placement of 66,800 units.

NPR will use the proceeds from the issuance to repay bridge loans used to acquire five Class-A properties forJPY 45.5 billion (\$434 million). The properties were acquired from Prologis' wholly owned Japan portfolio. The assets, totaling approximately 2.4 million square feet (222,037 square meters), were made available to NPR through its sponsor support agreement with Prologis. The offering is expected to close in Japan Sept. 16, 2014.

NPR is a Japanese real estate investment trust managed by a wholly owned subsidiary of Prologis.
